RULES AND REGULATIONS & AGREEMENT OF STUDENT & GUARDIAN

- 1. Students will not be permitted to leave the campus during class time without the prior permission/sanction of the Principal.
- 2. Unauthorised absence from the classes will be taken seriously and disciplinary action will be taken. Sanction should be obtained from the HOD in advance for all absence. Application for leave to be submitted on the day they come to the college after leave
- 3. The application for condonation of shortage of attendance has to be submitted to the Principal with sanctioned leave application within 2 days of last working day.
- 4. As per the High Court order mobile phones are restricted inside the College campus. Strict disciplinary action, including ceizure of the mobile phone and fine will be taken on students who violate the above rule.
- 5. Students are expected to adhere to the dress code prescribed by the institution while in campus. Jeans and T-shirts are nor permitted. The ID card should be displayed whenever they are inside the campus. Strict disciplinary action will be taken on the spot against those who violate the dress code. Any change in the dress code is permitted only with the consent of the Principal.
- 6. Ragging in any form is strictly prohibited in the college according to the directions of the Government of India. Penal measures to those found guilty of ragging will extend up to immediate expulsion from the College.
- 7. The College properties should be handled with maximum care and everything possible should be done to preserve the cleanlines, and tidiness of the building, furniture, library, Collegee buses and premises. Fine will be imposed for damages to equipment, furniture, building, college buses etc.
- 8. The students shall be bound by all the rules and regulations framed by the University of Kerala as well as the rules and norms prescribed by the State/Central Government.
- 9. If a student discontinues the course he/she is liable to pay the whole fees of the course.
- 10. Prior permission of the principal is necessary for:
 - Organizing and attending special meeting, entertainment or special function in the college or its premises.
 - Inviting persons who are not the members of the College for any function in the campus
 - Collection or subscription of any trend in the College either from the students or from the staff.
